Prof. Dr. Fazil Apaydin is a full-time professor at Ege University Hospital, where he works on weekdays from 08:30 to 16:00. After university hours, he consults private patients at his office. Fellows will gain substantial exposure to rhinoplasty procedures and selected facial reconstruction cases at the university clinic. Associate Prof. Dr. Serçan Göde and Associate Prof. Dr. Isa Kaya also work in the same department, and fellows will have the opportunity to participate in their surgical cases as well. Aesthetic rhinoplasty and facial rejuvenation procedures are primarily performed in private settings, with a limited number of invasive cases such as blepharoplasty and facelift surgeries.

There will be hands on exposure to septorhinoplasty procedures, post traumatic facial reconstruction including multidisciplinary working within a complex facial trauma group. There are residents within the department so operative work will be shared appropriately between the fellow and resident. The fellow would also be able to assist in the private sector cases performed. We are the largest subspecialty tertiary referral unit in the UK. The work involved is exclusively Rhinoplasty, Rhinology and Anterior Skull Base Surgery with an outpatient caseload of over 2000 patients per annum. The unit performs more 150 complex septorhinoplasties and 150 sinus/skull base procedures per year (Charing Cross Hospital) with no general ENT work. In addition, 150-200 private practice procedures can be observed by the fellow in the London Clinic. The fellowship is accredited by the Royal College of Surgeons Senior Clinical Fellowship Scheme. The candidate is expected to participate in the management of patients in the outpatient clinics and operating theatre. He/she will work as a part of team comprising the supervisor, specialist 12 registrars and Foundation Year (FY) doctors. He/she is also expected to participate in the ongoing research. At least three presentations and three peer-reviewed publications will be expected in a twelve-month fellowship period. The appointee will also join in with the audit, clinical governance and teaching in the departments.
